GARAGE SALE GUIDELINES City Ordinance 2009-08

- 1) Only personal property may be sold. This may include clothing, equipment, furniture, household goods, etc. No property is to be acquired or consigned for the purpose of resale at your garage sale. The sale is limited to the **Permit Location Only**.
- 2) The maximum number of garage sales is limited to four (4) events per calendar year.
- 3) Each sale is limited to a maximum of two (2) consecutive days per event.
- 4) Sale items may be displayed in your front, side or rear yard, carport, patio, garage or in the house.
- 5) The permit must be posted in a conspicuous place and clearly visible from the street for the duration of the event.
- 6) One sign of not more than four (4) square feet shall be permitted to be displayed on the property of the residence where a garage sale is being conducted pursuant to a permit issued under this chapter.
 - a.) Such signs will be displayed only during the times of the sales as delineated on the permit.
 - b.) Any additional signs will only be displayed on private property only with the express consent of that property owner, in an amount no greater than one (1) sign per property, and will be of a size of not more than four (4) square feet.
 - c.) In no case shall the sign be placed on the public right-of-way.
 - d.) No sign shall be displayed for a period longer than twenty-four (24) hours following the conclusion of the yard sale.

VIOLATIONS

Please be aware if you are found in violation of the City of Oak Grove 2009-08 Garage Sale Ordinance, you may be subject to Municipal fines.
