**AN ORDINANCE OF THE CITY OF OAK GROVE, KENTUCKY REPEALING TAX LEVY
ORDINANCE 2021-06 AND ESTABLISHING THE TAX LEVY FOR CITY PURPOSES
FOR THE FISCAL YEAR BEGINNING JULY 1, 2021 AND ENDING JUNE 30, 2022**

NOW THEREFORE, BE IT ORDAINED BY THE CITY OF OAK GROVE, KENTUCKY:

That the following tax levy is hereby made for City purposes for the City of Oak Grove, Kentucky, for the fiscal year beginning July 1, 2021, and ending June 30, 2022, inclusive, to wit:

SECTION 1 – CITY LEVY

For the fiscal year beginning July 1, 2021, and ending June 30, 2022, inclusive, there is hereby made a levy of twenty-three point eight cents (\$.238) on each ONE-HUNDRED DOLLARS (\$100.00) of taxable real property, five cents (\$.05) on each ONE-HUNDRED DOLLARS (\$100.00) of taxable real property for the recreation tax pursuant to ordinance 2009-3, and eight point three-three cents (\$.0833) on each ONE-HUNDRED DOLLARS (\$100.00) of taxable personal property, tangible and intangible, where the same shall apply in said City, subject to taxation, for the following purposes:

For the General Fund of the City of Oak Grove of each ONE-HUNDRED DOLLARS (\$100.00) of assessed value of all property subject to taxation in the said City for the fiscal year.

SECTION 2 – PENTALTY & INTEREST

That upon all taxes levied herewith which are unpaid January 1, 2022, through January 31, 2022, shall have attached and added to on the said date, a penalty of five percent (5%) flat onto the total amount of said taxes then due and payable and a penalty of ten percent (10%) on payments received after February 1, 2022. Said taxes due and payable, along with penalty, shall be collected by the Finance Director.

SECTION 3 – DISCOUNT

That a discount of one percent (1%) be allowed on all taxes in the amount of one dollar (\$1.00) or more paid by November 1, 2021.

SECTION 4 – UNCONSTITUTIONALITY

Any and all existing ordinances inconsistent with this ordinance are hereby repealed. Should any part of this ordinance be void or unconstitutional, the remaining ordinance shall remain in full force and effect.

SECTION 5- EFFECTIVE DATE


