Tuesday, January 4, 2022 Regular City Council Meeting Oak Grove Council Chambers

The Oak Grove City Council met in regular session on Tuesday, January 4, 2022, at 6:00 p.m. The meeting was held in the Oak Grove Council Chambers located at 8505 Pembroke Oak Grove Road, Oak Grove, Kentucky. Present for the meeting were: Mayor Theresa Jarvis, City Attorney Mark Gilbert, Council Member Jean Leavell, Council Member Isaiah Spencer, Council Member Edward Cook, Council Member Jackie Oliver, Council Member Tim Johnson and Council Member Janet Edwards. Also present was Chief of Police Dennis Cunningham, Public Works Director Martin Nuss, Finance Director Bobbie Crawford, Community Center Director Melissa Lynch and City Clerk Angela Comperry. There were approximately 4 citizens in attendance.

CALL TO ORDER

Mayor Theresa Jarvis called the meeting to order at 6 p.m.

INVOCATION/PLEDGE OF ALLEGIANCE

Pastor Dan Herbster gave the invocation and led the group in the Pledge of Allegiance.

OPEN SESSION

Citizens Jennifer Sentman, Joseph Belew and Bill Belew spoke in open session.

Council Member Tim Johnson made a motion to put master meters in subdivisions to see how much water the city is losing. Council decided to discuss it later during legislative section.

MAYOR'S REMARKS/DEPT HEAD REPORTS

The mayor asked council to waive the \$250 water tap fee for Habitat for Humanity.

Council Member Tim Johnson made a motion to waive the water tap fee. It was seconded by Council Member Jackie Oliver. A voice vote was taken with all in favor.

The mayor announced that the Oak Grove Village TIF had been closed for failure to reach the required match. She also asked council to approve Public Works Director Martin Nuss to be appointed as a commissioner for the Logan/Todd Regional Water Council.

Council Member Janet Edwards made a motion to approve Martin Nuss to sit on the Logan/Todd Water Council. It was seconded by Council Member Isaiah Spencer. A voice vote was taken with all in favor.

The mayor also asked council to think about premium pay for employees who worked through Covid.

Finance Director Bobbie Crawford asked if there were any questions about the monthly finance report. She stated gravel, salt and other things that qualify that have been paid would be reimbursed out of municipal road funds.

Council Member Jackie Oliver made a motion approve vehicles for Chief Dennis Cunningham. It was seconded by Ed Cook. A voice vote was taken with all in favor.

Council Member Jean Leavell asked that a Committee of the Whole meeting be set to discuss mobile homes and where the property lines are. Council discussed searching for easements at the County Clerk's Office before setting another meeting.

Finance Director Bobbie Crawford asked council permission to roll the water C.D.'s into the water department checking account. Council members directed that the money not be spent but moved to the account for better interest.
