The Oak Grove City Council met in regular session on Tuesday, February 1, 2022, at 6:00 p.m. The meeting was held in the Oak Grove Council Chambers located at 8505 Pembroke Oak Grove Road, Oak Grove, Kentucky. Present for the meeting were: Mayor Theresa Jarvis, City Attorney Mark Gilbert, Council Member Jean Leavell, Council Member Isaiah Spencer, Council Member Edward Cook, Council Member Jackie Oliver, and Council Member Tim Johnson, and Council Member Janet Edwards. Also present was Assistant Chief of Police Victor Lynch, Public Works Director Martin Nuss, Finance Director Bobbie Crawford, and City Clerk Angela Comperry. There were approximately 4 citizens in attendance.

CALL TO ORDER

Mayor Theresa Jarvis called the meeting to order at 6 p.m.

MAYOR'S REMARKS/DEPT HEAD REPORTS

Mayor Theresa Jarvis announced the city's news would be included in the tourism newsletter. She gave information for citizens to sign up for Christian County Alert and gave current census results for the city.

ROLL CALL

Council Members Jean Leavell, Isaiah Spencer, Janet Edwards, Jackie Oliver, Tim Johnson and Edward Cook were present for the meeting making a quorum of the Oak Grove City Council.

APPROVAL OF CITY COUNCIL MINUTES

Council Member Tim Johnson made a motion to approve the council meeting minutes of January 18, 2022. It was seconded by Council Member Ed Cook. A voice vote was taken with all in favor.

UNFINISHED BUSINESS

Ordinance 2022-01 Budget Amendment, First Reading. City Council Member Jean Leavell asked City Attorney Mark Gilbert to read Ordinance 2022-01, An Ordinance Amending Ordinance 2021-07, the City of Oak Grove's Annual Budget for the Fiscal Year July 1, 2021, through June 30, 2022, by Estimating Revenues and Resources and Appropriating Funds for the Operation of the City Government and the Water Enterprise. Council Member Jean Leavell made a motion to approve Ordinance 2022-01. It was seconded by Council Member Isaiah Spencer. Ordinance 2022-02, Building and Zoning Fee Ordinance, First Reading. City Council Member Jean Leavell asked City Attorney Mark Gilbert to read Ordinance 2022-02, An Ordinance by the City of Oak Grove, Kentucky Amending Ordinance No. 2015-01 Concerning Building and Zoning Regulation Ordinances. Council Member Jean Leavell made a motion to approve Ordinance 2022-02. It was seconded by Council Member Jackie Oliver. A vote was taken as follows: Jean Leavell, yes; Isaiah Spencer, yes; Janet Edwards, yes; Edward Cook, yes; Jackie Oliver, yes; Tim Johnson, yes.

Rescue Funds, Premium Pay. Council discussed using rescue funds for premium pay. Council asked the finance director to make a report on the number of people eligible, the number of hours worked and the cost if \$5, \$10 or \$15 was added as premium pay.

Council discussed trash cans around the city and other trash issues. Council Member Isaiah Spencer asked for nominations from Oak Grove be made to the Human Relations Committee for Woman of the Year and for the Scholarship Program and also announced that the theme for Black History Month is "Promoting Good Health."

There was discussion about having an Oak Grove representative on the Board of Education.




