The Oak Grove City Council met in regular session on Tuesday, February 15, 2022, at 6:00 p.m. The meeting was held in the Oak Grove Council Chambers located at 8505 Pembroke Oak Grove Road, Oak Grove, Kentucky. Present for the meeting were: Mayor Theresa Jarvis, City Attorney Mark Gilbert, Council Member Jean Leavell, Council Member Edward Cook, Council Member Jackie Oliver, and Council Member Tim Johnson, and Council Member Janet Edwards. Council Member Isaiah Spencer was absent. Also present was Chief of Police Dennis Cunningham, Public Works Director Martin Nuss, Finance Director Bobbie Crawford, and City Clerk Angela Comperry. Ordinance 2022-01 Budget Amendment, Second Reading. City Council Member Janet Edwards asked City Attorney Mark Gilbert to read Ordinance 2022-01, An Ordinance Amending Ordinance 2021-07, the City of Oak Grove's Annual Budget for the Fiscal Year July 1, 2021, through June 30, 2022, by Estimating Revenues and Resources and Appropriating Funds for the Operation of the City Government and the Water Enterprise. Council Member Janet Edwards made a motion to approve Ordinance 2022-01. It was seconded by Council Member Jean Leavell. 
