Regular City Council Meeting Minutes
Oak Grove Council Chambers**

The Oak Grove City Council met in Regular Session on April 19, 2022, at 6:00 p.m. The meeting was held in the Oak Grove Council Chambers located at 8505 Pembroke Oak Grove Road Oak Grove, Kentucky. Present for the meeting were: Mayor Theresa Jarvis, Council Member Janet Edwards, Council Member Isaiah Spencer, Council Member Jean Leavell, Council Member Tim Johnson, Council Member Jackie Oliver, and Council Member Edward Cook. Also present for the meeting was City Attorney Mark Gilbert, City Clerk Lorelynn Fisher, Police Chief Dennis Cunningham, Public Works Director Martin Nuss, Finance Director Bobbie Crawford, and Community Center Director Melissa Lynch. There were approximately 12 people present for the meeting.

CALL TO ORDER

Mayor Theresa Jarvis called the meeting to order at 6:00pm.

INVOCATION/PLEDGE OF ALLEGIANCE

Pastor Dan Herbster led those present in the Invocation and Pledge of Allegiance

OPEN SESSION

Lloyd Walters voiced his appreciation for our Oak Grove Police Department who made a successful bust. He also voiced his opinion and stated that while the city is looking for loans to repair pipes, he thinks sidewalks should be incorporated/done at the same time.

MAYOR'S REMARKS/DEPT HEAD REPORTS

Mayor Theresa Jarvis stated that she traveled to Richmond for the Grand Opening Ceremony for Buc-ees. She said the place was packed and how eager she is for this to be coming to Oak Grove.

ROLL CALL

Council Member Janet Edwards, Council Member Isaiah Spencer, Council Member Jean Leavell, Council Member Tim Johnson, Council Member Jackie Oliver, and Council Member Edward Cook were in attendance. A quorum was present.

APPROVAL OF CITY COUNCIL MINUTES

Mayor Jarvis asked City Council to make a motion to approve the minutes from the regular council meeting on April 5, 2022. Council Member Jean Leavell made a motion to approve the minutes. Council Member Isaiah Spencer seconded the motion. There was no discussion. A voice vote was taken with all in favor; the motion carried.

UNFINISHED BUSINESS

Water Rates- Finance Director Bobbie Crawford stated that Council Member Janet Edwards asked for a report that shows the average water bill calculated based on the number of meters and how many gallons. Crawford stated that the average residential water bill uses just under forty-six hundred gallons a month. The average increase if the 17% rate was passed would be approximately \$4.00-\$6.00 dollars per month. Discussion was held. Council Member Tim Johnson made a motion to move forward with drafting the ordinance including the 17% increase. Council Member Isaiah Spencer seconded the motion. More discussion was held. Roll call vote was as follows: Council Member Jean Leavell-yes, Council Member Isaiah Spencer-yes, Council Member Janet Edwards-yes, Council Member Tim Johnson-yes, Council Member Jackie Oliver-yes, and Council Member Edward Cook-no. The motion carried with 5 in favor and 1 opposed.

Rescue Funds/Premium Pay- Council Member Janet Edwards made a motion to do \$2.00 per hour premium pay up to a max of \$2,500.00 based on original timeframe (March 26, 2020-June 11, 2021) for employees. Council Member Tim Johnson seconded the motion. There was no discussion. Roll call vote was as follows: Council Member Janet Edwards-yes, Council Member Tim Johnson-yes, Council Member Jean Leavell-yes, Council Member Edward Cook-no, Council Member Jackie Oliver-yes. Council Member Isaiah Spencer was recused. The motion carried with 4 in favor, 1 opposed, and 1 recused.

Council Member Jean Leavell made a motion to go into Executive Session per KRS 61.810 (c) pending litigation and (f) personnel. Council Member Isaiah Spencer seconded the motion. There was no discussion. A voice vote was taken with all in favor; the motion carried.

EXECUTIVE SESSION (KRS 61.810)

Council Member Tim Johnson made a motion to go back into open session. Council Member Jean Leavell seconded the motion. There was no discussion. A voice vote was taken with all in favor; the motion carried.

No action was taken.

NEW BUSINESS

Resolution 2022-01 Standard Allowance for ARPA Funds- Mayor Theresa Jarvis read out loud Resolution 2022-01. Council Member Janet Edwards made a motion to approve Resolution 2022-01. Council Member Edward Cook seconded the motion. There was no discussion. A voice vote was taken with all in favor; the motion carried.




