



# Thursday, August 4, 2022 Committee of the Whole Special Meeting Minutes Oak Grove Council Chambers

The Oak Grove Committee of the Whole met in special session on Thursday, August 4, 2022, at 6:00 p.m. in the Oak Grove City Council Chambers located at 8505 Pembroke Oak Grove Rd Oak Grove, Kentucky. <u>Occupational License Ordinance No. 2008-05:</u> Discussion was held regarding enforcement, seasonal licenses, internet businesses and other general matters. City Attorney is looking into options for enforcement. No action was officially taken.

#### Ordinance 2022-XX Compensation Plan:

Council Member Isaiah Spencer recused himself for this discussion. Council requested to amend the current Compensation Ordinance in effect and move the Code Enforcement Officer/Zoning Inspector position from a grade 36 to a grade 37. They also requested to move Major/PD position from a grade 46

to a grade 47 and to bring forth said changes to the next regular council meeting. Council also requested the city implement the step program for the city.
