



**Tuesday September 13, 2022**  
**Special City Council Meeting Minutes**  
**Oak Grove Council Chambers**

The Oak Grove City Council met in Special Session on September 13, 2022, at 2:00 p.m. The meeting was held in the Oak Grove Council Chambers located at 8505 Pembroke Oak Grove Road Oak Grove, Kentucky. Present for the meeting were: Mayor Theresa Jarvis, Council Member Janet Edwards, Council Member Isaiah Spencer, Council Member Jean Leavell, Council Member Jackie Oliver, and Council Member Edward Cook. Council Member Jean Leavell made a motion to go into Executive Session per KRS 61.810(1)(b) Possible Development Purposes-Purchase of Land Acquisition. Council Member Isaiah Spencer seconded the motion. There was no discussion. A voice vote was taken with all in favor; the motion carried.
