AN ORDINANCE OF THE CITY OF OAK GROVE, KENTUCKY,
ADOPTING THE PROVISIONS OF SUBDIVISION GUIDELINES OF
OAK GROVE, KENTUCKY, IN ORDER TO PROVIDE FOR A SAFE
AND ORDERLY SUBDIVISION OF LAND WITHIN THE CORPORATE
LIMITS OF OAK GROVE, KENTUCKY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF OAK
GROVE, KENTUCKY:

SECTION I

That a new Chapter and Section of the Oak Grove Code of Ordinances be established in accordance with the language and provisions of the Subdivision Guidelines of Oak Grove, Kentucky, a copy of which is attached hereto and which has been duly considered by the City Council, after three (3) public hearings held on January 29, 1990, February 27, 1990, and March 26, 1990, a copy of which is on file in the office of the City Clerk of the City of Oak Grove, Kentucky.

SECTION II

Subdivision Guidelines of Oak Grove, Kentucky, a copy of which is attached hereto, is hereby adopted by reference and as an Ordinance of this City, the same as if set out at length, in words and figures herein. It shall be a part of the Code of Ordinances of the City of Oak Grove, Kentucky, and the language and sections of said ordinance shall be codified and become and be made a part of the Code of Ordinances, Oak Grove, Kentucky, and the sections of said ordinance may be renumbered to accomplish the intention of the Council in accordance therewith.

SECTION III

That all ordinances or parts of ordinances in conflict with this ordinance are hereby repealed.
