#### SECTION 1

That a certain document, three (3) copies of which are on file in the office of the City Clerk of Oak Grove, being marked and designated as the International Property Maintenance Code, 2015 edition, as published by the International Code Council, be and is hereby adopted as the Property Maintenance Code of the City of Oak Grove, State of Kentucky, for regulating and governing the conditions and maintenance of all property, buildings and structures; by providing the standards for supplied utilities and facilities and other physical things and conditions essential to ensure that structures are safe, sanitary and fit for occupation and use; and the condemnation of buildings and structures unfit for human occupancy and use, and the demolition of such existing structures as herein provided; providing for the issuance of permits and collection of fees therefor; and each and all of the regulations, provisions, penalties, conditions and terms of said Property Maintenance Code on file in the office of the City Clerk and attached hereto as Exhibit 1, are hereby referred to, adopted and made a part hereof, as if fully set out in this legislation with the additions, insertions, deletions and changes, if any, prescribed in Section 2 of this ordinance.

All enforcement of this ordinance shall be the responsibility of the Code or Building Official and the Code and Nuisance Board or Christian County District Court.

That if any section, subsection, sentence, clause or phrase of this legislation is, for any reason, held to be unconstitutional, such decision shall not affect the validity of the remaining portions of this ordinance. The City Council of the City of Oak Grove, Kentucky, hereby declares that it would have passed this law, and each section, subsection, clause or phrase thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses and phrases be declared unconstitutional.
