



**Tuesday March 21, 2023
Special City Council Meeting Minutes
Oak Grove Council Chambers**

The Oak Grove City Council met in Special Session on March 21, 2023, at 5:00 p.m. The meeting was held in the Oak Grove Council Chambers located at 8505 Pembroke Oak Grove Road Oak Grove, Kentucky. Present for the meeting were: Mayor Jacqueline Oliver, Council Member Janet Edwards, Council Member Isaiah Spencer, Council Member Jean Leavell, Council Member John Campbell (arrived 10 minutes late), and Council Member Edward Cook. EXECUTIVE SESSION

Discussion/Hearing for Ethics Complaint-61.810(1)(f) Discussions or hearings which might lead to the appointment, discipline, or dismissal of an individual, employee, member, or student without restricting that employee's, member, or student's right to a public hearing if requested. This exception shall not be interpreted to permit discussion of general personnel matters in secret: Council Member Jean Leavell made a motion to enter into Executive Session 61.810 (1)(f) Discussion and hearing of ethics complaint. Council Member Edward Cook seconded the motion. Council Member Janet Edwards informed citizens that council is conducting a preliminary hearing for an ethics complaint they received. A voice vote was taken with all in favor; the motion carried.
