



# Tuesday March 21, 2023 Special City Council Meeting Minutes Oak Grove Council Chambers

The Oak Grove City Council met in Special Session on March 21, 2023, at 5:00 p.m. The meeting was held in the Oak Grove Council Chambers located at 8505 Pembroke Oak Grove Road Oak Grove, Kentucky. # **EXECUTIVE SESSION**
