Special City Council Meeting Minutes
Oak Grove Council Chambers**

The Oak Grove City Council met in Special Session on April 28, 2023, at 6:00 p.m. The meeting was held in the Oak Grove Council Chambers located at 8505 Pembroke Oak Grove Road Oak Grove, Kentucky.
