### CITY OF OAK GROVE, KENTUCKY ORDINANCE NO. 2023-XX

## AN ORDINANCE BY THE CITY OF OAK GROVE, KENTUCKY ESTABLISHING THE POSITION OF AND COMPENSATION LEVEL FOR TEMPORARY-PART TIME MAINTENANCE WORKER AND AMENDING ORDINANCE NO. 2022-08

WHEREAS, on August 1, 2022, the City of Oak Grove passed Ordinance No. 2022-08, which established a plan for the city employees; and

WHEREAS, the city now wishes to establish the position of Temporary-Part Time Maintenance Worker for the Roads and Grounds Department, and set the compensation level for this position; and

WHEREAS, the City Council believes that the implementation of said changes in the best interests of the City of Oak Grove and its citizens.

NOW THEREFORE, be it ordained by the City of Oak Grove, Kentucky as follows:

SECTION I – ESTABLISHMENT OF POSITION OF TEMPORARY-PARTIME MAINTENANCE WORKER

The position of Temporary-Part Time Maintenance Worker for the City of Oak Grove Roads and Grounds is hereby established. The pay grade for this position shall be (33). A job description for this position is attached hereto and is labeled Exhibit 1. This position shall be incorporated into the City of Oak Grove Compensation Table, dated August 2022, and City of Oak Grove Position Grade Assignment, dated August 1, 2022. Ordinance No. 2022-08-Attachment A- "Compensation Table & Position Grade Assignment August 1, 2022" is hereby amended as set out in Exhibit 2 – Compensation Table & Position Grade Assignment.

#### SECTION II – UNCONSTITUTIONALITY

Any and all existing ordinances inconsistent with this ordinance are hereby repealed. Should any part of this ordinance be void or unconstitutional, the remaining provisions of this ordinance shall remain in effect.

City maintenance workers may also be tasked with performing minor repairs to public property or equipment. This might include fixing potholes in the road, replacing street signs that have fallen over, etc.			
Essential Duties:	<ul> <li>Maintains grounds, including but not limited to, watering, seeding and maintenance of all landscape features and plantings such as grass, trees, shrubs, and flowers.</li> <li>Ensure prompt removal of trash and debris.</li> <li>Perform routine ground maintenance, including mowing, weed eating, edging, pruning, trimming, mulching, etc.</li> </ul>			
Reasoning Ability:	<ul> <li>Ability to interpret regulations, and statutes from local, state, and federal governments. Possess the ability to discuss and resolve complicated situations with the public.</li> <li>Able to work under stress is necessary.</li> </ul>			
Preferred Skills, Knowledge, or Abilities:	<ul> <li>Prior mowing/bush hogging experience preferred.</li> <li>Must be able to successfully operate various types of outdoor equipment with minimum supervision.</li> </ul>			
Work Environment:	<ul> <li>Work environment has a degree of risk of exposure to various types of infectious diseases. This position requires entrance into confined spaces and ambulating over rugged terrain to physically inspect conditions of various roads and city property.
