



# Tuesday June 6, 2023 Regular City Council Meeting Minutes Oak Grove Council Chambers

The Oak Grove City Council met in Regular Session on June 6, 2023, at 6:00 p.m. The meeting was held in the Oak Grove Council Chambers located at 8505 Pembroke Oak Grove Road Oak Grove, Kentucky. Present for the meeting were: Mayor Jacqueline Oliver, Council Member Janet Edwards, Council Member Isaiah Spencer, Council Member Jean Leavell, Council Member Richard Baker, Council Member John Campbell, and Council Member Edward Cook. - 1. <u>Swearing in of New Code Enforcement Officer/Zoning Inspector-Kinshasa Burgess:</u> City Clerk, Lorelynn Fisher, administered the Oath of Office to Kinshasa Burgess.
- 2. <u>Discussion of/Approval of Job Descriptions:</u> Committee Chair, Janet Edwards, informed council that the committee had conducted a follow up meeting earlier in the day and not all job descriptions have been completed as there is a lot of work involved in the process. The job descriptions should be completed at the next scheduled committee meeting on June 16, 2023, and should be ready for council the following week.
- 3. <u>Municipal Order 2023-02 Establishing Regulations for Administering the City's Classification and Compensation Plan:</u> Council Member Janet Edwards made a motion to table this until job descriptions

- have been approved. Council Member John Campbell seconded the motion. There was no discussion. A voice vote was taken with all members present in favor; allowing the motion to pass.
- 4. Ordinance 2023-XX An Ordinance Adopting the City of Oak Grove's Annual Budget for Fiscal Year July 1, 2023, through June 30, 2024, by estimating revenues and resources and appropriating funds for the operation of the city government and the water enterprise: Council Member Janet Edwards asked the City Attorney to read ordinance 2023-XX. The City Attorney read aloud said ordinance. Council Member Isaiah Spencer made a motion to accept. Council Member John Campbell seconded the motion. Discussion was held. - 5. <u>Surplus Property for Auction-2015 Nissan Altima:</u> Mayor informed council that this item of business is being removed as the city is not auctioning the vehicle.
- 6. <u>Surplus Property for Auction-Utility Truck:</u> Council Member Jean Leavell made a motion to auction the utility truck. Council Member John Campbell seconded the motion. There was no discussion. A voice vote was taken with all members present in favor; allowing the motion to pass.
- 7. <u>Discussion of rebranding the Community Center:</u> The following topics were discussed: Name of the center-Lisenbee, media sites, programs, and activities.

- 1. <u>Solar Farm Ordinance-Attorney update:</u> City Attorney, Mark Gilbert, advised council that he will speak with Tom Britton from CDS to write up the official contract.
- 2. <u>Hugh Hunter Rd Construction and other construction sites-Bidding:</u> Mayor Oliver and Brian Ahart stated Hugh Hunter was on the MPO list.
- 3. <u>Showers at the Community Center:</u> Council Member Edward Cook asked that the showers be utilized for their purpose instead of storage at the center.
- 4. <u>Sign for Community Center-Bidding:</u> City Clerk, Lorelynn Fisher, informed council that she was advised by the Mayor and Finance Director to wait to bid until the new fiscal year when money would be allocated in the budget. Fisher also informed the council that the City Attorney reviewed and approved the bid information she wrote earlier today, and she would send it out for bidding soon.
- 5. <u>New property-Attorney update:</u> City Attorney, Mark Gilbert, advised council that he is waiting on a more readable/larger version of the document for David Cuttoff.
- 6. <u>List of grants being applied for-Mayor update:</u> Mayor Oliver advised the council on several grants which includes Fire Department, KDLA Records, Body Cams, Vests, Tasers, Water Tower, FEMA Grants, and Parks.
- 7. <u>Water Leak Satellite-Mayor Update:</u> Fields Operations Manager, Brandy Moore, presented the council with a presentation of areas where leaks were potentially detected within the city.

Various other topics were discussed among the council which included Challenge coins for Oak Grove, Cards for Oak Grove, Feed bins, Murals, City seal, Proclamation for Juneteenth, Parks, and upcoming events within the city.
