The Oak Grove City Council on September 5, 2023, at 6:00 p.m. The meeting was held in the Oak Grove Council Chambers located at 8505 Pembroke Oak Grove Road Oak Grove, Kentucky. Appointment of Tim Johnson as a regular member to the Code Enforcement and Nuisance Board for a three-year term: Council Member Isaiah Spencer made a motion to approve Tim Johnson to the Code Enforcement and Nuisance Board.
