



Tuesday, November 7, 2023 Regular City Council Meeting Minutes Oak Grove Council Chambers

The Oak Grove City Council on November 7, 2023, at 6:00 p.m. The meeting was held in the Oak Grove Council Chambers located at 8505 Pembroke Oak Grove Road Oak Grove, Kentucky. Present for the meeting were: Mayor Jacqueline Oliver, Council Member Isaiah Spencer, Council Member Richard Baker, Council Member John Campbell, Council Member Janet Edwards, and Council Member Edward Cook. Council Member Jean Leavell was absent. Also present for the meeting were City Attorney Mark Gilbert, Police Chief Dennis Cunningham, Fire Chief Bill Johnson, Public Works Director Brian Ahart, Field Operations Manager Brandy Moore, Human Resources Hailey Bamford, and City Clerk Lorelynn Fisher. Council Member John Campbell made a motion to table both items of business until the December 5, 2023, city council meeting. Council Member Richard Baker seconded the motion. Discussion was held. A voice vote was taken with all members present in favor; the motion passed.
- 4. Establishment of a subcommittee for the Goals and Objectives of Oak Grove: Dicussion was held among the city council. It was decided that Council Members Isaiah Spencer and John Campbell serve on this committee. The city council asked City Clerk Lorelynn Fisher to post an ad advertising for 3 (three) residents/business owners to serve on this committee totaling 5 committee members. Council Member Isaiah Spencer asked this be put on the December council agenda.
- 5. <u>Economic Development Committee:</u> Dicussion was held among the city council. It was decided that Council Members Janet Edwards and Richard Baker serve on this committee along with the Executive Director of Tourism, the Public Works Director, and 1 (one) resident/business owner. The city council asked City Clerk Lorelynn Fisher to post an ad advertising for 1 (one) resident/business owner. This topic was asked to be put on the December council agenda.
- 6. <u>Establishment of a subcommittee for Ordinance 2016-01 Stormwater Regulations:</u> Discussion was held among the city council. It was decided that this ordinance be sent to the Zoning Committee. It was also discussed that CDS review/update this ordinance since they originally drafted it.
- 7. <u>Proclamation proclaiming November 11, 2023, as Veterans Day in the City of Oak Grove, Kentucky:</u> Mayor Oliver read aloud the proclamation proclaiming November 11, 2023, as Veterans Day in the City.

1. <u>Introduction of Sara Stone-Animal Control Officer:</u> Ms. Stone introduced herself to the city council and answered questions. The city council welcomed her and complimented her on her hard work. The city council asked that she update the council every so often on what she is doing in the city.

Mayor Oliver presented City Attorney Mark Gilbert with a certificate of appreciation for his dedication to Oak Grove for the last four years. Mayor Oliver wished Mr. Gilbert the best in his next endeavor.

The city council discussed the establishment of a Steering Committee. It was decided that Council Members Edward Cook, Janet Edwards, and Jean Leavell serve on this committee. The city council asked City Clerk Lorelynn Fisher to post an ad advertising for interested individuals. The purpose of this committee is to plan, coordinate, and implement annual holiday events in Oak Grove.

Various other topics were discussed including an update on Good Hope Cemetery Road, a discussion of Ordinance 2016-01, an update on the water line project, an update on the paving bid, a discussion on CPR/AED classes, and an update on the sign at the community center.
