



**Monday, February 12, 2024
Special City Council Meeting Minutes

The Oak Grove City Council met on February 12, 2024, at 5:00 p.m. The meeting was held in the Oak Grove Council Chambers located at 8505 Pembroke Oak Grove Road Oak Grove, Kentucky.
