



Tuesday, January 2, 2024 Regular City Council Meeting Minutes Oak Grove Council Chambers

The Oak Grove City Council met on January 2, 2024, at 6:00 p.m. The meeting was held in the Oak Grove Council Chambers located at 8505 Pembroke Oak Grove Road Oak Grove, Kentucky.
