



Thursday, June 1, 2023 Committee of the Whole Special Meeting Minutes Oak Grove Council Chambers

The Oak Grove Committee of the Whole met in special session on Thursday, June 1, 2023, at 6:00 p.m. in the Oak Grove City Council Chambers located at 8505 Pembroke Oak Grove Rd Oak Grove, Kentucky. Attending the meeting were: Chairman/Council Member Jean Leavell, Council Member Richard Baker, Council Member Janet Edwards, Council Member John Campbell, and Council Member Edward Cook. There was approximately 1 individual present at the meeting.

OPENING CEREMONIES

Council Member Richard Baker made a motion to dispense formalities. Council Member Edward Cook seconded the motion. There was no discussion. A voice vote was taken with all present in favor; the motion carried.

Playground Committee: Update on parks, equipment, funding, ideas, and plans: The Playground Committee presented the Committee of the Whole with a video presentation and various ideas that were discussed at their committee meeting. Some ideas that were discussed included Adopt a Highway/City Road, Implementing the Cemetery as a Historical Landmark, basketball courts and pickleball at the playground behind the fire station, and turning the softball field into a soccer field at Wades Way Park. The Playground Committee also advised the Committee of the Whole about various grants that are being looked into. The Committee of the Whole asked the Playground Committee to continue looking into money/grants.
