## Public Notice: FEMA Assistance That May Affect Floodplains, Wetlands or Historic Properties in Kentucky

**FRANKFORT, Ky.** – FEMA has posted a public notice detailing its intent to provide disaster assistance to eligible applicants for eligible costs to repair or replace homes damaged by the May 21-27 severe storms, straight-line winds, tornadoes, landslides and mudslides.

Under the July 23 presidential major disaster declaration, FEMA has been authorized to provide, through its Public Assistance Program, reimbursement or direct Federal assistance to eligible state, local, tribal and certain private-non-profit organizations applicants for emergency work including Direct Federal Assistance for Adair, Allen, Ballard, Barren, Breckenridge, Butler, Caldwell, Calloway, Carlisle, Christian, Clay, Clinton, Crittenden, Cumberland, Edmonson, Estill, Fulton, Garrard, Graves, Grayson, Green, Harlan, Hart, Hickman, Hopkins, Jackson, Knox, Larue, Laurel, Lee, Leslie, Livingston, Logan, Lyon, Marshall, McCracken, McCreary, McLean, Meade, Menifee, Metcalfe, Monroe, Muhlenberg, Ohio, Owsley, Perry, Pulaski, Rockcastle, Russell, Simpson, Todd, Trigg, Warren, Washington, Wayne, Whitley, and Woodford counties in the Commonwealth of Kentucky. The Hazard Mitigation Grant Program is available statewide.

This public notice concerns activities that may affect historic properties, activities that are located in or may otherwise affect wetland areas or the 100-year floodplain, and critical actions within the 500-year floodplain. Such activities may adversely affect historic properties, floodplains or wetlands, or may result in continuing vulnerability to flood damage.

FEMA has determined that for certain types of facilities there are normally no alternatives to restoration in the floodplain or wetland. FEMA intends to provide assistance for the restoration of these facilities to their pre-disaster condition, except that certain measures to mitigate the effect of future flooding or other hazards may be included in the work.

FEMA also intends to provide Hazard Mitigation Grant Program funding to mitigate future disaster damage.
