



**Thursday, September 19, 2024**  
**Special City Council Meeting Minutes**  
**Oak Grove Council Chambers**

The Oak Grove City Council convened on September 19, 2024, at 5:00 p.m. The session took place at the Oak Grove Council Chambers, located at 8505 Pembroke Oak Grove Road, Oak Grove, Kentucky. Mayor Jacqueline Oliver, along with Council Members Jean Leavell, Richard Baker, Janet Edwards, Edward Cook, and Isaiah Spencer, were in attendance. Also present were City Attorney Lee Wilson, Assistant Police Chief Victor Lynch, Tourism's Executive Director Traci Cunningham, and City Clerk Lorelynn Fisher. There were approximately zero individuals in attendance.

**CALL TO ORDER**

Mayor Jacqueline Oliver called the meeting to order at 5:00 p.m.

**OPENING CEREMONIES**

Council Member Janet Edwards moved to dispense with formalities, and Council Member Isaiah Spencer seconded. A voice vote was conducted, and the motion passed unanimously.

**REVIEW OF MINUTES**

A roll call vote was conducted with Council Members Spencer, Baker, Edwards, and Cook in favor; Council Member Jean Leavell abstained from the vote, and Council Member John Campbell was absent. - **Proposed Ordinance 2024-XX: An Ordinance Establishing the Tax Levy for city purposes for the Fiscal Year Beginning July 1, 2024, and Ending June 30, 2025- Second reading:**

Council Member Janet Edwards requested Mr. Wilson to read the ordinance aloud, and he complied by doing so. Council Member Janet Edwards moved to approve the ordinance, and Council Member Isaiah Spencer seconded. A roll call vote was conducted with Council Members Edwards, Baker, Cook, and Spencer in favor; Council Member Jean Leavell abstained from the vote, and Council Member John Campbell was absent. The motion passed.

Council Member Isaiah Spencer moved to adjourn the meeting, and Council Member Richard Baker seconded. A voice vote was conducted, and the motion passed unanimously. The meeting was adjourned at approximately 5:06 p.m.
