Special City Council Meeting Minutes
Oak Grove Council Chambers

The Oak Grove City Council convened on January 30, 2025, at 5:30 p.m. The session took place at the Oak Grove Council Chambers, located at 8505 Pembroke Oak Grove Road, Oak Grove, Kentucky. Mayor Jacqueline Oliver, along with Council Members Jean Leavell, Richard Baker, John Campbell, and Janet Edwards, were in attendance. City Attorney Lee Wilson, Police Chief Dennis Cunningham, and City Clerk Lorelynn Fisher were also present. There were approximately five individuals present. Council Members Edward Cook and Isaiah Spencer were absent.

CALL TO ORDER

Mayor Jacqueline Oliver called the meeting to order at 5:30 p.m.

ROLL CALL OF ATTENDANCE

Council Members Jean Leavell, Richard Baker, John Campbell, and Janet Edwards were in attendance, constituting a quorum. Council Members Edward Cook and Isaiah Spencer were absent.

APPROVAL OF MINUTES

Mayor Jacqueline Oliver requested the minutes from the meeting on January 21, 2025, be approved. Council Member Richard Baker moved to approve, and Council Member John Campbell seconded. A voice vote was conducted, and the motion passed.

NEW BUSINESS

- **Discussion of investigations of the handling of the allegations of Code Enforcement/Code Enforcement Procedures:** Discussion was held between the city council and the mayor regarding harassment allegations concerning the Code Enforcement Officer and a business owner in Oak Grove. Council stated that they are trying to figure out what allegations are right and what allegations are wrong. Mayor Oliver presented a detailed timeline of the citations and violations in question. Police Chief informed the council that the department did an investigation and everything the officer did, and the city did was 100% correct and no arrest were made. Council Member John Campbell moved to have council investigate the allegations and get sworn statements from employees that were involved or have information, and Council Member Janet Edwards seconded. A voice vote was conducted, and the motion passed. City Clerk Lorelynn Fisher questioned which employees council would

like sworn statements from and the council requested the following individuals:
Mayor, Public Works Director, Chief of Police, Code Enforcement Officer, Detective
assigned to the case, and the City Maintenance Supervisor.
