
If you choose not to contest the citation and pay the penalty to the City within seven (7) days, the fine for this offense is \$500.00

If you choose to contest the citation and request a hearing before the Code of Ordinance Enforcement Board, the maximum penalty that may be imposed for this violation is \$500.00 Failure to pay the applicable civil penalty or request a hearing, in writing, from the Nuisance and Code Enforcement Board within seven (7)days of the issuance of this citation shall constitute a waiver of your right to contest the citation and the determination that a violation was committed shall be final and nonappealable.

According to Oak Grove Ordinance 2021-13, the Nuisance & Code Enforcement Board shall have the power to issue remedial order and impose civil fines as a method of enforcing city ordinances. The person to whom the citation is issued shall respond to the citation within seven (7) days of the date of issuance by either paying the civil fine or requesting in writing, a hearing before the Nuisance & Code Enforcement Board to contest the citation. If the person fails to respond to the citation within seven (7) days, the person shall be deemed to have waived the right to a hearing and the determination that a violation was committed shall be considered final.

### FINDINGS OF FACT, CONCLUSIONS OF LAW AND ORDER

RE: VIOLATION OF ORDINANCE NO. 2020-06

The Code Enforcement and Nuisance Board enters the following FINDINGS OF FACT, CONCLUSIONS OF LAW AND ORDER.

#### **FINDINGS OF FACT**

The respondent(s) WALKER, MORGAN E., are the owner(s) of the property located at 311 Alan Ct., Oak Grove, KY 42262 (146-02 00 073.00).

The respondent(s) was issued a citation by the Code Enforcement Officer dated April 29, 2025, for violation of City ordinance(s) 2020-06.

The respondent(s), WALKER, MORGAN E., neglected to respond to the citation within seven (7) days as required by KRS 65.8825.

The Code Enforcement and Nuisance Board find, based on all evidence presented at the Code Enforcement and Nuisance Board Meeting, that the condition described in the citation did, in fact, exist at the time the citation was issued, that the condition did constitute a violation of city ordinance(s) 2020-06, of the City of Oak Grove, and that the condition was caused by, or was the responsibility of the respondent(s) as owner(s)s, or person(s) in charge of the property on which the violation occurred.

### **CONCLUSIONS OF LAW**

The board concludes, based on the foregoing Finding of Fact, that respondent(s), has committed a violation of city ordinances 2020-06 of the City of Oak Grove, Kentucky, as charged in the citation.

#### ORDER

It is hereby ordered on the 15 day of May 2025, by the Code Enforcement and Nuisance Board the Respondent(s), WALKER, MORGAN E., shall pay a civil fine to the City of Oak Grove a \$500.00 citation fee, \$60.00 administrative/filing fee, and an abatement fee of \$130.00, totaling a sum of \$690.00, plus any interest that may accrue from this date forward. Therefore, a certified copy of this order, together with a claim of lien, shall be recorded in the Office of the County Clerk, and once recorded, along with all charges
