



# Thursday, May 29, 2025 Special City Council Meeting Minutes Oak Grove Council Chambers

The Oak Grove City Council convened on May 29, 2025, at 5:00 p.m. The session took place at the Oak Grove Council Chambers, located at 8505 Pembroke Oak Grove Road, Oak Grove, Kentucky. Mayor Jacqueline Oliver, along with Council Members Jean Leavell, Richard Baker, John Campbell, Isaiah Spencer, Janet Edwards, and Edward Cook were in attendance. City Attorney Lee Wilson, Police Chief Dennis Cunningham, Fire Chief Bill Johnson, Finance Director Matt Egbert, and City Clerk Lorelynn Fisher were also present. There were approximately zero individuals present.

Roll call vote was as follows: Council Members Campbell, Edwards, Leavell, Spencer, Baker, and Cook voted in favor. The motion passed.
