

**ORDINANCE NO. 2025-XX  
CITY OF OAK GROVE, KENTUCKY**

**AN ORDINANCE OF THE CITY OF OAK GROVE, KENTUCKY REPEALING  
ORDINANCES 1988-3, 1990-10, 1992-1, 1992-9, 1993-11, 1995-7, 1995-8, 1996-16,  
2000-23, 2001-25, 2015-01, AND 2022-02 ESTABLISHING BUILDING REGULATIONS  
AND FEES**

**WHEREAS** the repealing of these ordinances will aid in streamlining regulatory processes, eliminating confusion, and promoting efficiency in the administration of city laws.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF OAK GROVE, KENTUCKY  
THAT ORDINANCE NO. 2025-XX IS HEREBY READ AS FOLLOWS:**

**SECTION 1-REPEALING OF ORDINANCES**

Ordinance No. 1988-3, enacted on the 15<sup>th</sup> day of February 1988, requiring contractors and builders to inform the City of Oak Grove of the identity of all subcontractors, is hereby repealed in its entirety.

Ordinance No. 1990-10, enacted on the 20<sup>th</sup> day of October 1990, establishing building permit fees and license tax, is hereby repealed in its entirety.

Ordinance No. 1992-1, enacted on the 17<sup>th</sup> day of April 1992, providing that section I 150.04 (a) of the building permit and license tax Ordinance No. 1990-10 be amended, is hereby repealed in its entirety.

Ordinance No. 1992-9, enacted on the 30<sup>th</sup> day of January 1993, providing that 150.04(a) of the building permit and license tax ordinance No. 1990-10 and 1992-1 be amended, is hereby repealed in its entirety.

Ordinance No. 1993-11, enacted on the 1<sup>st</sup> day of November 1993, providing that 150.04(a) of the building permit and license tax ordinance No. 1990-10 and No. 1992-1 be amended, is hereby repealed in its entirety.

Ordinance No. 1995-7, enacted on the 20<sup>th</sup> day of May 1995, amending 150.04, building permits; where obtained; fees, is hereby repealed in its entirety.

Ordinance No. 1995-8, enacted on the 29<sup>th</sup> day of September 1995, amending Ordinance No. 1991-4 Article VIII Section 8.8B Billboards-Commercial/Industrial amending section 150.04(a) (1) fees for permanent signs and amending section 110.18 business license tax for outdoor advertising, is hereby repealed in its entirety.

Ordinance No. 1996-16, enacted on the 23<sup>rd</sup> day of September 1996, providing that 150.04 (a) of the building permit and license tax ordinance Nos. 1990-10, 1992-1, and 1993-11 be amended, is hereby repealed in its entirety.

Ordinance 2000-23, enacted on the 16<sup>th</sup> day of November 2000, providing that section 150.04(a) of the code of ordinances. Ordinances Nos. 1990-10, 1992-1, 1993-11 and 1996-16 be amended, is hereby repealed in its entirety.

Ordinance No. 2001-25, enacted on the 26<sup>th</sup> day of October 2001, establishing new building regulations and fee schedules and repealing all previous building regulations ordinances, is hereby repealed in its entirety.

Ordinance No. 2015-01, enacted on 2<sup>nd</sup> day of March 2015, amending ordinance No. 2001-25 concerning building regulations ordinances, is hereby repealed in its entirety.

Ordinance No. 2022-02, enacted on 24<sup>th</sup> day of February 2022, amending ordinance No. 2015-01 concerning building and zoning regulations ordinances, is hereby repealed in its entirety.

## **SECTION 2-SAVINGS CLAUSE**

Permits prosecution for violations of the ordinances listed in Section 1, provided the violation(s) occurred during the period the ordinances were in effect.

## **SECTION 3-SEVERABILITY**

It is the legislative body's intent that the provisions of this ordinance are to be severable and that if a part of this ordinance is to be invalid, the findings do not necessarily invalidate the entire ordinance.

## **SECTION 4-UNCONSTITUTIONALITY**

Should any part of this ordinance be void or unconstitutional, the remaining ordinance shall remain in full force and effect.

**SECTION 5-EFFECTIVE DATE**

This ordinance shall take effect after its passage and publication according to law.
