The Code Enforcement and Nuisance Board enters the following FINDINGS OF FACT, CONCLUSIONS OF LAW AND ORDER.

FINDINGS OF FACT

The respondent, FIKE, PAUL, is the owner of property located at, 155 Lillian Dr., Oak Grove, KY 42262 (163-03 00 073.00).

The respondent, FIKE, PAUL, was issued a citation by the Code Enforcement Officer dated August 5, 2025, for violation of City ordinance 2020-06.

The respondent, FIKE, PAUL, neglected to respond to the citation within 7 days as required by KRS 65.8825.
