CALL TO ORDER

- Mayor Jacqueline Oliver called the meeting to order at 6:00 p.m.

OPENING CEREMONIES

- Pastor Nicholson led the Invocation and the Pledge of Allegiance.

OPEN FORUM

- **Mr. Cobb:** Stated that he was verbally abused by Council Member Cook at an event and requested a formal apology. Mr. Cook addressed licensing matters, then issued an apology, and the two shook hands. Mr. Cobb also spoke about his work at the Community Center, commended Melissa Lynch for her outstanding contributions, and expressed concern that it was unfair she was let go. He requested an explanation for her dismissal.
- **Alvia Littleton:** Addressed the termination of Melissa Lynch, speaking highly of her leadership and the positive impact she made as Director of the Community Center.

- **Buc-ee's Update:** Surveying has begun for the tank location. Building plans have been approved and site plans are under review.
- **Waterlines Update:** Surveying is underway for the installation of new lines on Hugh Hunter Road and Highway 115.
- **Water Meters:** The City continues daily installations, with approximately 50% completed; all meters have been acquired.
- **FEMA Meeting:** Discussed reimbursement for City expenditures, with a 60-day submission window. Dumpsters remain eligible for reimbursement for about one more month. A follow-up meeting will be scheduled.
- **Code Enforcement:** Council Member Edwards inquired about code enforcement activity.

Fire Chief Bill Johnson

- Reported 57 calls for service in August. Current roster includes 31 personnel. Announced an Open House scheduled for October 11, 2025, from 11:00 a.m. to 2:00 p.m.

Assistant Police Chief/ Major Victor Lynch

- Reported traffic activity in Oak Grove, including 202 non-injury accidents, 44 accidents with injuries, 1,957 traffic stops, 38 theft reports, and 641 citations issued. Commended officers for their hard work and performance.

Ahart stated that decisions regarding additional roads are at the discretion of the developer. Ahart will contact the State regarding the matter. Discussion took place with citizens and City Council regarding sidewalks and road widening. Ahart noted that the City is a member of the MPO.

- Council Member Janet Edwards and City Council Discussion

Reported receiving numerous messages, emails, and phone calls regarding the termination of Director Lynch. Inquired about the plan for the Community Center and noted that the director position should be changed from an executive to a supervisor role. Respectfully requested that City Council be informed of any major changes regarding significant city matters. Other issues were discussed from city council, residents, and Mayor Oliver.
