## **AGENDA ITEMS**

• Job Descriptions: The committee will review job descriptions, encompassing the job title, department, supervisor, grade, FLSA status, salary range, and job details and Compensation/Step Plan: The committee will review the city's compensation and step plan for employees: The committee met to review and discuss several staffing positions and made the following recommendations:

- Community Center/Parks and Recreation Director The committee recommended moving this position from the Executive Band to Grade 40.
- Community Center Customer Service It was agreed that staffing should include one full-time Customer Service Representative and two part-time employees.
- City Maintenance Supervisor The committee recommended changing the title of "Temporary Part-Time Maintenance Work (Roads and Grounds)" to "Maintenance Worker." This role would report directly to the City Maintenance Supervisor.
- Accounting Support Specialist After reviewing the responsibilities of Accounts
   Payable and Accounts Receivable, the committee felt these should be split into two
   separate positions. HR will consult with the Finance Director regarding this
   recommendation.
- Utility Office Manager The committee recommended adding language to the job description to clearly include accounts payable and receivable duties.
- Code Enforcement Officer/Zoning Inspector The prospect of moving this role up one grade was debated. The committee decided to keep the position at its current grade for now, with plans to reconsider the matter next year and explore the option of adding a part-time officer.
- Firefighters The committee recommended removing "Full-Time Firefighter" from Grade 39. Part-time Firefighters will remain listed in Grade 35 as "Firefighters."

The next committee meeting is scheduled for September 16, 2025, at 9:30 a.m.
