



**Oak Grove Fire/Public Safety Committee
Regular Session Meeting Minutes
Thursday, July 10, 2025
Oak Grove Council Chambers**

CALL TO ORDER

The Regular Session of the Oak Grove Fire/Public Safety Committee was called to order by Chairperson Edward Cook at 6:01 p.m. on Thursday, July 10, 2025, in the Oak Grove Council Chambers at 8505 Pembroke Oak Grove Road, Oak Grove, Kentucky.

ROLL CALL

The following members were present:

- Chairperson/Committee Member Edward Cook
- Committee Member Isaiah Spencer

Police Chief Dennis Cunningham, Fire Chief Bill Johnson, and City Clerk Lorelynn Fisher were also present. Committee Member John Campbell was absent. Approximately one member of the public was in attendance.

REVIEW OF MINUTES

Committee Member Isaiah Spencer moved to approve the minutes from the April 10, 2025, meeting, seconded by Chairperson/Committee Member Edward Cook. No discussion followed, and the motion passed by voice vote.

AGENDA ITEMS

1. **Grants:** The committee, together with the two chiefs, explored several potential grants that the city could consider applying for, such as the Firehouse Subs grant, Walmart Grant, FD Assistance Grant, and others.
2. **Storage Containers:** Containers were bought and placed at the Fire Station.

3. **Vehicle Replacement/Refurbishment:** Chief Johnson informed the committee that the city should consider replacing or refurbishing its fire trucks. He noted that he had previously requested this be included in the city's budget, but it was not approved. He urged the city to develop a plan and stated he would explore various options to determine the most cost-effective solution.
4. **New Station:** The initial steps are still underway, with the city currently looking into plans and drawings for a building.
5. **Replacement of Parking/Aprons:** Chief Johnson inquired about repaving the back parking lot. The committee recommended he reach out to Finance Director Egbert to obtain numbers.

Additional topics that were discussed were Police and Fire personnel.

ADJOURNMENT

Committee Member Isaiah Spencer moved to adjourn the meeting, seconded by Chairperson/Committee Member Edward Cook. No discussion followed, and the motion passed by voice vote. The meeting was adjourned at approximately 6:32 p.m.
