CALL TO ORDER

Mayor Jacqueline Oliver called the meeting to order at 6:00 p.m.

OPENING CEREMONIES

- Invocation/Pledge of Allegiance: Council Member Spencer led the Invocation and the Pledge of Allegiance.

OPEN FORUM

- Amir McCain: Addressed the City Council with general suggestions and comments regarding recent incidents within the city. Spoke about the denial of the proposed homeless shelter, emphasizing that neighbors should help neighbors, stating “Bring hope, not harm” and “The only impossibility is impossibility.” He inquired whether anyone had contacted property owners about construction near the basin on Shadow Ridge and asked if there was information on what is being built at the corner of Hugh Hunter Road and Pembroke Oak Grove Road.
- Christine Kuba: Addressed the City Council regarding stormwater mitigation. She reported that Brian Storz, Division of Water’s Licking River Basin Coordinator, has agreed to visit Oak Grove to provide information on local water issues if the mayor and city council members are interested.
