Committee Member Janet Edwards presented a draft outline of a strategic plan for the City of Oak Grove, which included vision and mission statements, as well as strategic goals. The committee recommended the following changes and additions:

Vision Statement:

- Add the phrase: "Your destination for every occasion."
- Remove the word "her" when referring to Oak Grove.
- Include descriptive words such as "original" and "genuine."

Mission Statement:

- Reformat into bullet points.
- Incorporate language emphasizing "harmony," "strength," and "stability."
- Revise bullet point #3: change "Foster" to "Strengthen."
- Add a sixth bullet point.

Strategic Goals:

- Discuss goals, objectives, strategies, and tactics related to infrastructure.
- Review potential incentives for residents, including a city-owned solid waste franchise, healthcare options, and establishing an economic development fund for future projects.
