AN ORDINANCE AMENDING ORDINANCE 2022-03, THE CITY OF OAK GROVE'S ANNUAL BUDGET FOR THE FISCAL YEAR JULY 1, 2021, THROUGH JUNE 30, 2022, BY ESTIMATING REVENUES AND RESOURCES AND APPROPRIATING FUNDS FOR THE OPERATION OF THE CITY GOVERNMENT AND THE WATER ENTERPRISE.

WHEREAS, KRS 424.240 requires that immediately following the adoption of an annual budget by any city other than one of the first class, the City Clerk shall cause a summary of the budget or the text of the budget ordinance to be advertised for the city by publication in a newspaper"; and

WHEREAS, a first reading of the Amended Oak Grove Budget Ordinance 2022-06 was held on June 7, 2022; and

WHEREAS, a second reading of the Amended Oak Grove Budget Ordinance 2022-06 was held on June 21, 2022; and

WHEREAS, the proposed budget showing anticipated receipts of \$9,871,600 and expenditures of \$9,871,600; and

WHEREAS, the City Council has reviewed said budget proposal and made necessary modifications;

NOW THEREFORE, BE IT ORDAINED BY THE CITY OF OAK GROVE, KENTUCKY, that the following budget is adopted for the fiscal year July 1, 2021, through June 30, 2022, and the amounts stated are appropriated for the purpose indicated. The mayor is authorized to expend these funds as budgeted without further approval of the City Council.


