**AN ORDINANCE BY THE CITY OF OAK GROVE, KENTUCKY ESTABLISHING
COMPENSATION FOR BOARD OF ZONING ADJUSTMENT MEMBERS**

WHEREAS provisions need to be made for the compensation of members who serve on the Board of Zoning Adjustment;

**NOW THEREFORE, BE IT ORDAINED BY THE CITY OF OAK GROVE, KENTUCKY
THAT ORDINANCE 2022-09 READS AS FOLLOWS:**

SECTION I-COMPENSATION OF BOARD MEMBERS

Members of the Board of Zoning Adjustment shall be reimbursed for actual expenses and compensated in the amount of \$25.00 (twenty-five dollars) per meeting, with the chairperson receiving \$30.00 (thirty dollars) per meeting.

SECTION II-SEVERABILITY CLAUSE

It is the legislative body's intent that the provisions of this ordinance are to be severable, and that if a part of this ordinance is deemed invalid, unconstitutional, or void, the findings shall not invalidate the remaining provisions of this ordinance.

SECTION III-CONFLICTING ORDINANCES

Any and all existing ordinances inconsistent with this ordinance are hereby repealed.


SECTION IV-EFFECTIVE DATE
