City of Oak Grove Ordinance No. 2020-13, Section 2.03 shall be amended to read as follows:

No sexually oriented business, other than adult novelty centers, shall be or remain open for business between the hours of 12:00 A.M. and 12 P.M. on any one day. No adult novelty center shall be or remain open between the hours of 3:00 A.M. and 9 A.M.

Second Reading this 4 day of October 2022.
