**SECTION I-MEETING DAY, TIME, AND LOCATION**

The Ethics Committee will conduct regular meetings on the 2<sup>nd</sup> Wednesday of each quarter at 3:00pm. Ethics Committee meetings will be held in the Council Chambers located at 8505 Pembroke Oak Grove Road, Oak Grove, Kentucky 42262.

**SECTION II-SEVERABILITY CLAUSE**

It is the legislative body's intent that the provisions of this ordinance are to be severable, and that if a part of this ordinance is deemed invalid, unconstitutional, or void, the findings shall not invalidate the remaining provisions of this ordinance.

**SECTION III-CONFLICTING ORDINANCES**

Any and all existing ordinances inconsistent with this ordinance are hereby repealed.

**SECTION IV-EFFECTIVE DATE**

This ordinance shall take effect upon passage and publication according to law.


