WHEREAS, The Oak Grove City Council has determined it is in the best interest of the citizens, news media, and council to establish a firm day, time, and location to conduct regular city council meetings.

NOW THEREFORE, BE IT ORDAINED BY THE OAK GROVE CITY COUNCIL OF OAK GROVE, KENTUCKY THAT ORDINANCE 2023-14 READS AS FOLLOWS:

SECTION ONE – THE DAY, TIME, AND LOCATION OF
REGULAR CITY COUNCIL MEETINGS

The Oak Grove City Council shall conduct regular city council meetings on the first and third Tuesday of each month at the hour of 6:00pm CST. City council meetings shall be held in the City Council Chambers located at 8505 Pembroke Oak Grove Rd, Oak Grove, Kentucky 42262.

If a regular scheduled city council meeting falls on an established holiday, a regular city council meeting shall be scheduled for the following day at the same time and location as above.

SECTION TWO - SEVERABILITY

It is the legislative body's intent that the provisions of this ordinance are to be severable, and that if a part of this ordinance is to be invalid, the findings do not necessarily invalidate the entire ordinance.

SECTION THREE- EFFECTIVE DATE

This ordinance shall take effect after its passage and publication according to law.
