**AN ORDINANCE BY THE CITY OF OAK GROVE, KENTUCKY
REPEALING ORDINANCES 1984-7, 2002-08, 2013-01, 2015-03, 2016-04, AND 2020-03
RELATING TO THE ESTABLISHMENT OF A DAY, TIME, AND LOCATION FOR
REGULAR CITY COUNCIL MEETINGS**

WHEREAS, it is in the City of Oak Grove's best interest to repeal all existing ordinances of the city relating to the establishment of regular city council meetings;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF OAK GROVE, KENTUCKY THAT ORDINANCE NO. 2023-15 HEREBY READS AS FOLLOWS:

SECTION ONE- REPEALING OF EXISTING ORDINANCES

Ordinance No. 1984-7, enacted on 16 day of July 1984, and relating to the adoption and setting of a time and place for regular meetings of the city council, is hereby repealed in its entirety.

Ordinance No. 2002-08, enacted on 19 day of April 2002, and relating to the establishment of a day, time, and location for regular city council meetings, is hereby repealed in its entirety.

Ordinance No. 2013-01, enacted on 24 day of April 2013, and relating to the amendment of Ordinance No. 2002-08 establishing a day, time, and location for regular council meetings, is hereby repealed in its entirety.

Ordinance No. 2015-03, enacted on 14 day of February 2015, and relating to the amendment of Ordinance No. 2013-01 establishing a day, time, and location for regular council meetings, is hereby repealed in its entirety.

Ordinance No. 2016-04, enacted on 28 day of July 2016, and relating to the amendment of Ordinance No. 2015-03 establishing a day, time, and location for regular council meetings, is hereby repealed in its entirety.

Ordinance No. 2020-03, enacted on 15 day of February 2020, and relating to the amendment of Ordinance No. 2016-04 establishing a day, time, and location for regular council meetings, is hereby repealed in its entirety.

SECTION TWO – SEVERABILITY CLAUSE

It is the legislative body's intent that the provisions of this ordinance are to be severable, and that if a part of this ordinance is to be invalid, the findings do not necessarily invalidate the entire ordinance.

SECTION THREE-EFFECTIVE DATE

This ordinance shall take effect after its passage and publication according to law.

Ordinance No. 2015-03, enacted on 14 day of February 2015, and relating to the amendment of Ordinance No. 2013-01 establishing a day, time, and location for regular council meetings, is hereby repealed in its entirety.

Ordinance No. 2016-04, enacted on 28 day of July 2016, and relating to the amendment of Ordinance No. 2015-03 establishing a day, time, and location for regular council meetings, is hereby repealed in its entirety.

Ordinance No. 2020-03, enacted on 15 day of February 2020, and relating to the amendment of Ordinance No. 2016-04 establishing a day, time, and location for regular council meetings, is hereby repealed in its entirety.
