VOLUNTEER FIRE COMMITTEE MEMBERSHIP AMENDMENT

AN ORDINANCE AMENDING ORDINANCE 2023-01 AMENDING MEMBERSHIP OF THE
VOLUNTEER FIRE COMMITTEE TO INCORPORATE AND INCLUDE THE
MEMBERSHIP OF THE PUBLIC SAFETY COMMITTEE FOR THE CITY OF OAK GROVE,
KENTUCKY

WHEREAS, the City of Oak Grove enacted Ordinance 2023-01 adopting a regular meeting schedule of the Volunteer Fire Committee for the City of Oak Grove; and

WHEREAS, the Oak Grove City Council wishes to combine the membership of the Public Safety Committee into the Volunteer Fire Committee; and

NOW THEREFORE BE IT ORDAINED BY THE CITY OF OAK GROVE, KENTUCKY AS FOLLOWS:

SECTION I. AMENDMENT OF OAK GROVE ORDINANCE 2023-01

City of Oak Grove Ordinance 2023-01 is hereby amended as follows:

**SECTION I. MEETING [DAY, TIME, AND LOCATION]
SCHEDULE, MEMBERSHIP, AND INCORPORATION
OF PUBLIC SAFETY COMMITTEE**

The Volunteer Fire Committee will conduct regular meetings on the 2nd Thursday of each quarter at 6:00 pm. The Volunteer Fire Committee meetings will be held in the Council Chambers located at 8505 Pembroke Oak Grove Rd, Oak Grove, Kentucky 42262.

Membership on the Volunteer Fire Committee shall include all individuals appointed to the committee as well as all individuals serving as members of the Public Safety Committee as of the effective date of this Ordinance.

Further, the City of Oak Grove, Kentucky Public Safety Committee shall henceforth be incorporated into the Volunteer Fire Committee and the Public Safety Committee shall no longer be a standing committee of the City of Oak Grove, Kentucky.

All remaining provisions of City of Oak Grove Ordinance 2023-01 shall remain in full force and effect.

SECTION II. SEVERABILITY

It is the legislative body's intent that the provisions of this ordinance are to be severable and that if a part of this ordinance is to be invalid, the findings do not necessarily invalidate the entire ordinance.

SECTION III. EFFECTIVE DATE


This ordinance shall take effect after passage and publication according to law.


