WHEREAS, it is in the City of Oak Grove's best interest to repeal all existing Tax Levy ordinances of the city;

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF OAK GROVE, KENTUCKY, ORDINANCE 2023-17 IS HEREBY ADOPTED AS FOLLOWS:

SECTION THREE- SEVERABILITY CLAUSE

It is the legislative body's intent that the provisions of this ordinance are to be severable, and that if a part of this ordinance is to be invalid, the findings do not necessarily invalidate the entire ordinance.

SECTION FOUR- EFFECTIVE DATE




