#### CALL TO ORDER

- Mayor Jacqueline Oliver called the meeting to order at 6:00 p.m.

#### OPENING CEREMONIES

#### REPORTS OF OFFICERS, BOARDS, & COMMITTEES

Mayor Oliver:

- Reported that Director Ahart indicated the company will resume paving in the next couple of days as temperatures rise within the city.

Police Chief Victor Lynch:

- In March, there were 191 traffic stops, 23 arrests, and 26 reports generated. Officers responded to 9 collisions with no injuries and spent a total of 83 hours in February on alcohol-related accidents.

Council Member Spencer:

- Inquired about the Job Fair at the Community Center.

## UNFINISHED BUSINESS

- Zoning Ordinance 2021-11-RV Parks  
*(Council discussion regarding permitting RV parks):*  
Council Member Jean Leavell asked that a letter of request be prepared by Riddle to obtain general information about the RV park, including its layout and number of units. Council Member Leavell stated that the zoning committee agreed it is a positive step and would like to move forward. No official action was taken.

## NEW BUSINESS

- Proclamation-Women’s History Month  
*(Proclamation acknowledging the importance of honoring women’s contributions to society):*  
The Mayor read aloud a proclamation declaring March 2026 as Women’s History Month in the City of Oak Grove.
- Solid Waste Management  
*(Request for Proposal to Provide Solid Waste Collection Services in the City-Council approval to solicit bids):*  
**Motion:** Council Member Janet Edwards moved to solicit the bids  
**Second:** Council Member Isaiah Spencer  
**Vote:** Voice  
**Results:** Passed
- Municipal Order 2026-XX  
*(Order outlining the rules and regulations for all non-ordinance boards and committees):*  
Council Member Edwards asked City Attorney to read aloud the order, Wilson complied.  
**Motion:** Council Member Isaiah Spencer moved to accept the order  
**Second:** Council Member John Campbell  
**Roll Call Vote:** Members Cook, Spencer, Edwards, Leavell, Baker, and Campbell all voted in favor  
**Results:** Passed
- Resolution 2026-XX  
*(Resolution initiating a zoning text amendment to establish standards for the placement of qualified manufactured homes within the city and make amendments in accordance with KRS 100.348):*  
Council Member Edwards asked City Attorney to read aloud the resolution, Wilson complied.  
**Motion:** Council Member Janet Edwards moved to accept the resolution  
**Second:** Council Member Jean Leavell  
**Roll Call Vote:** Members Leavell, Edwards, Campbell, Spencer, Baker, and Cook all voted in favor  
**Results:** Passed

## LEGISLATIVE BODY MEMBER COMMENTS

- Full-Time Mayor Position: Council discussion on the potential transition to a full-time mayor:  
Council Member Spencer stated that he believes the position should be full-time. Council Member Campbell agreed, adding that while it should be designated as a full-time position, the salary should remain unchanged until the city establishes a paid fire department.

- City Council Compensation: Council discussion on salary options for the next legislative term: Council Member Spencer discussed increasing compensation for the next elected council, noting that council members have never received a raise. Council Member Edwards stated that members should receive a cost-of-living adjustment (COLA) rather than a raise, acknowledging that the time and skill required exceed current compensation, and suggested revisiting the matter in two years. Council Member Campbell agreed that both positions deserve higher compensation but only after a paid fire department is established. Council Member Spencer emphasized that he is not motivated by money but believes the positions should be better compensated, a viewpoint supported by both Edwards and Campbell. Council Member Leavell shared that in 1994, when council members were paid \$25, she returned each check to the city to support the fire department.

**Motion:** Council Member Janet Edwards moved to stop all merit raises until further notice

**Second:** Council Member Jean Leavell

City Attorney Lee Wilson advised Council Member Edwards that merit raises are the responsibility of the executive branch, not the legislative branch. Council Members Edwards and Leavell both withdrew their motions. More discussion was held regarding raises. Council Member Edward Cook requested the Finance Director’s attendance at the next meeting.

- Bulk Waste Pickup: Council discussion regarding bulk waste collection: Council Member Edward Cook stated that several residents have inquired about bulk pickup. Mayor Oliver explained that the temporary contract does not include bulk pickup, which is why the city is providing dumpsters for residents. Dumpsters will be available each month until the new franchise takes effect. Code violations will be enforced for residents who move out and leave piles of trash.
