**AN ORDINANCE BY THE CITY OF OAK GROVE, KENTUCKY, REPEALING  
SEVERAL ORDINANCES RELATING TO THE SEWER AND WATERWORK  
SYSTEMS OF THE CITY OF OAK GROVE, KENTUCKY**

**WHEREAS** the City of Oak Grove finds it beneficial to repeal these ordinances to improve the organization of ordinances and eliminate inconsistencies.

**NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF OAK GROVE, KENTUCKY, ORDINANCE 2025-02 IS HEREBY ADOPTED AS FOLLOWS:**

**SECTION I- REPEALING OF ORDINANCES**

Ordinance No. 1985-6, enacted on the 15<sup>th</sup> day of August 1985, relating to the establishment of water tapping fees and rates, is hereby repealed in its entirety.




