

**ORDINANCE NO 2025-04  
CITY OF OAK GROVE, KENTUCKY**

**AN ORDINANCE ENACTED BY THE CITY OF OAK GROVE, KENTUCKY,  
REPEALING VARIOUS ORDINANCES RELATED TO SUBDIVISION GUIDELINES.**

**WHEREAS** the City of Oak Grove finds it beneficial to repeal these ordinances to improve the organization of ordinances and eliminate inconsistencies.

**NOW THEREFORE, BE IT ORDAINED BY THE CITY OF OAK GROVE, KENTUCKY  
AS FOLLOWS:**

**SECTION I- REPEALING OF ORDINANCES**

Ordinance No. 1990-7, enacted on the 17<sup>th</sup> day of August 1990, relating to the adoption of subdivision guidelines, is hereby repealed in its entirety.

Ordinance No. 1991-7, enacted on the 14<sup>th</sup> day of December 1991, relating to the amendment of section 4.2, B 2 and 3 of the subdivision guidelines, is hereby repealed in its entirety.

Ordinance No. 1998-13, enacted on the 6<sup>th</sup> day of November 1998, relating to the amendment of the subdivision guidelines, is hereby repealed in its entirety.

Ordinance No. 1999-02, enacted on the 15<sup>th</sup> day of January 1999, relating to the amendment of Ordinance 1998-13, is hereby repealed in its entirety.

**SECTION II- SAVINGS CLAUSE**

Permits prosecution for violations of the ordinances listed in Section I, provided the violation(s) occurred during the period the ordinances were in effect.

**SECTION III- SEVERABILITY CLAUSE**

The legislative body intends that this ordinance's provisions are severable and that the findings do not necessarily invalidate the entire ordinance if a part of it is invalid.

**SECTION IV- EFFECTIVE DATE**






