##### Police Chief Victor Lynch:

- School will soon be dismissing for the summer. Residents are encouraged to keep vehicles locked and avoid leaving valuables inside. Traffic conditions have improved, although there is still a significant amount of traffic in the area. The Spring Into Summer Festival was also discussed.

##### Fire Chief Bill Johnson:

- In March, there were 78 calls for service with an average response time of 11.7 minutes. In April, there were 69 calls for service with an average response time of 13.1 minutes. The current ISO rating remains at 3.

**Finance Director Matt Egbert:**

- Reported that the 2024 audit has been completed. All FEMA reimbursement funds have been received. The software conversion process is progressing well. The UFIR has been received and accepted by the State of Kentucky-the city is in good standing.

- Council Member John Campbell: Provided an update on the yard contest. Judging will take place during the last week of each month. The contest will include six zones, six judges, and six winners. Carneal and Bumpus Mill have been added to Judge Cunningham’s zone.
- Council Member Isaiah Spencer: Encouraged the public to visit and support the Wings of Liberty Museum on Fort Campbell. The museum will educate visitors while honoring the service and sacrifice of those who have served at Fort Campbell, including the 101st Airborne Division, 5th Special Forces Group, and 160th Special Operations Aviation Regiment.
