CALL TO ORDER

- Mayor Jacqueline Oliver called the meeting to order at 6:00 p.m.

OPENING CEREMONIES

- Invocation/Pledge of Allegiance: Pastor Nicholson led the Invocation and the Pledge of Allegiance.

OPEN FORUM

- Roger Joiner questioned why the speed limit on Hugh Hunter Road is set at 35 mph. He expressed concern that children living along Hugh Hunter Road are no less important than children in other residential neighborhoods where the speed limit is 25 mph and asked that the speed limit be reviewed.

REPORTS OF OFFICERS, BOARDS, & COMMITTEES

Community Center/Parks and Recreation Director Eric Hauser

- Reported that Gun Violence Awareness Day was a success. Council Member Isaiah Spencer spoke at the event, and representatives from the Police Department and Fire Department were also in attendance. Director Hauser stated the Community Center has a new Nonverbal Mission's message which is "Unity in the Community."

- Hauser announced that the Christian County Summer Feeding Program will run from June 1 through July 31. Dawn with Mission of Hope will host the Ron Brown Memorial Lunch Program, providing free bag lunches to anyone in the community who needs a meal.

Police Chief Victor Lynch

- Reported more than 64 hours of alcohol-related enforcement activity during May, including 25 hours of A.I. (Alcohol Initiative) activity, 18 hours of DUI enforcement, and 3 hours of domestic-related activity. There were 10 injury-related traffic accidents and several welfare checks conducted during the month. Lynch also reminded residents to be mindful of traffic congestion, monitor children's activities during the summer months, and remain alert to potential scams.

Finance Director Matt Egbert

- Reported that the Fiscal Year 2024 audit has been completed. The Utility Post system has gone live, and staff are currently addressing minor issues. A new online utility payment portal is expected to go live within the next week.

Public Works Director Brian Ahart

- Mayor Oliver read Ahart's email to council stating that a construction meeting was held with Phoenix Tank to discuss the project timeline, which had expired and was subsequently rebid. Water loss continues to remain stable, and meter changeouts are progressing well. The Community Center parking lot has been striped and is now complete.

Mayor Oliver

- Addressed confusion regarding the new trash service provider. Residents who receive their water bill from the City of Oak Grove do not need to contact Impact Waste Service to establish service.
- Residents who receive water service from another provider must contact Impact Waste Service to set up service.
- Existing senior discounts will continue. Residents who qualify for this discount can call the Water Department to set up if they are not currently receiving the discount.
- Residents should wait until they receive their first curbside cart before requesting an additional cart, which can be arranged through the Water Department.

Council Member Edward Cook also stated that the City of Hopkinsville is developing language regarding AI data centers and will share that information with Oak Grove for consideration in determining how the city wishes to proceed.

LEGISLATIVE BODY MEMBER COMMENTS

- **Council Member Janet Edwards:** Invited residents to attend Cookies with Council on Saturday at the Community Center. Council Members Edwards, Leavell, and Campbell will be in attendance.
- **Council Member John Campbell:** Encouraged all women veterans to attend the Women's Veterans Recognition Day event on June 12 and asked veterans to submit photographs for display to janet.edwards@oakgroveky.org. He also reminded residents of the upcoming Juneteenth Proclamation reading at the Community Center and announced the Yard of the Month winners. He expressed appreciation to all residents who continue to maintain their properties and keep their yards well-kept.
- **Council Member Isaiah Spencer:** Spoke about Gun Violence Awareness efforts and emphasized the importance of personal responsibility and community involvement. Council Member Isaiah Spencer highlighted the many community events available for children and families and encouraged residents to work together to promote unity within the community.
- **Council Member Jean Leavell:** Expressed concerns regarding the condition of streets, easements, and rights-of-way throughout the city. She noted that grass is growing rapidly and stated that Oak Grove needs additional cleanup efforts. Council Member Jean Leavell reminded residents that, pursuant to city ordinance, property owners are responsible for maintaining easements adjacent to their property. She also raised concerns regarding wrecked vehicles being stored in yards and Council Member Edward Cook stated issues involving trailers on residential properties.
