

**ORDINANCE NO 2026-04
CITY OF OAK GROVE, KENTUCKY**

ELECTRICAL INSPECTION FEES

AN ORDINANCE PERTAINING TO ELECTRICAL INSPECTION FEES FOR THE
CITY OF OAK GROVE, KENTUCKY

WHEREAS, KRS§227.480(1) requires persons to obtain a permit before commencing construction, alteration, or repairs of any electrical wiring; as defined by the provisions of the Uniform State Building Code; and

WHEREAS, the City of Oak Grove desires to codify the procedures for the issuance of electrical permits;

NOW THEREFORE, BE IT ORDAINED BY THE CITY OF OAK GROVE, KENTUCKY AS FOLLOWS:

SECTION I. ELECTRICAL PERMIT APPLICATION, ISSUANCE AND FEES

1. Electrical permits required for work to be performed in the City of Oak Grove shall be obtained from Oak Grove City Hall.

2. Individuals required by state law to obtain an electrical permit may file an application with City Hall in the manner and form required by the City. The City may charge a Sixty-Five and 00/100 Dollars (\$65.00) fee for the purpose of processing electrical permit applications.

3. All property owners, builders or contractors which are required to obtain an electrical permit shall obtain a permit from the City prior to the performance of any work where state law requires the issuance of a permit.

4. All duly authorized electrical inspectors acting on behalf of the City shall be in possession of a permit prior to performing an electrical inspection as required by state law. Upon completion of the electrical inspection, inspectors acting on behalf of the City shall present a copy of their inspection report to the City.

5. All electrical inspectors acting on behalf of the City through a duly authorized contract are permitted to charge only the fees below for inspections. Inspections fees shall be paid directly to the inspector. Permit fees shall be paid directly to City Hall. paid

6. If upon an electrical inspection, the wiring or electrical facilities cannot be approved at that time, a reinspection fee of \$30.00 shall apply for each reinspection in addition to mileage and travel time, as authorized in paragraph 7 below.

7. An inspector may charge, in addition to the inspection fee, an amount necessary for travel to and from the inspection site, including both mileage and travel time. If two or more inspections are made during one trip, the cost of travel shall be divided between inspections.

SECTION II. SEVERABILITY

It is the legislative body’s intent that the provisions of this ordinance are to be severable and that if a part of this ordinance or its incorporated attachment is to be invalid, the findings do not necessarily invalidate the entire ordinance.

SECTION III. UNCONSTITUTIONALITY

Should any part of this ordinance or its incorporated attachment be void or unconstitutional, the remaining ordinance and its incorporated attachment shall remain in full force and effect.

SECTION IV. EFFECTIVE DATE


This ordinance and its incorporated attachment shall take effect after its passage and publication according to law.





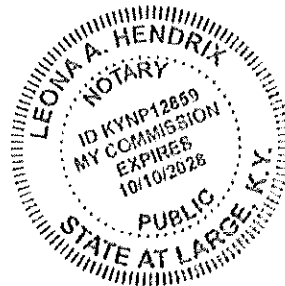
