

**ORDINANCE NO. 2026-XX
CITY OF OAK GROVE, KENTUCKY**

**AN ORDINANCE BY THE CITY OF OAK GROVE, KENTUCKY, REPEALING
SEVERAL ORDINANCES RELATING TO ALCOHOLIC BEVERAGE REGULATIONS
IN THE CITY OF OAK GROVE, KENTUCKY**

WHEREAS the City of Oak Grove finds it beneficial to repeal these ordinances to improve the organization of ordinances and eliminate inconsistencies.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF OAK GROVE, KENTUCKY, ORDINANCE 2026-XX IS HEREBY ADOPTED AS FOLLOWS:

SECTION I- REPEALING OF ORDINANCES

Ordinance No. 1976-12, enacted on the 9th day of August 1976, imposing a license tax or fee for beer, is hereby repealed in its entirety.

Ordinance No. 1976-13, enacted on the 9th day of August 1976, relating to the licensing and regulation of the sale, transportation, possession, or other disposition of spirituous, vinous or intoxicating malt liquors, is hereby repealed in its entirety.

Ordinance No. 1986-5, enacted on the 13th day of June 1986, amending ordinance 1976-12 is hereby repealed in its entirety.

Ordinance No. 1994-2, enacted on the 21st day of January 1994, amending ordinance 1976-12, is hereby repealed in its entirety.

Ordinance No. 2013-08, enacted on the 8th day of November 2013, establishing regulations for the sale or serving of alcoholic beverages, is hereby repealed in its entirety.

Ordinance No. 2020-01, enacted on the 18th day of January 2020, amending ordinance 2013-08, is hereby repealed in its entirety.

SECTION II- SAVINGS CLAUSE

Permits prosecution for violations of the ordinances listed in Section I, provided the violation(s) occurred during the period the ordinances were in effect.

SECTION III- SEVERABILITY CLAUSE

The legislative body intends that this ordinance's provisions are severable and that the findings do not necessarily invalidate the entire ordinance if a part of it is invalid.

SECTION IV- EFFECTIVE DATE

According to law, this ordinance shall take effect after its passage and publication.
