CALL TO ORDER

- Presiding Officer Janet Edwards called the meeting to order at 6:00 p.m.

OPENING CEREMONIES

- Invocation/Pledge of Allegiance: Pastor Nicholson led the Invocation and the Pledge of Allegiance.

OPEN FORUM

- **Sam Stephan** expressed concerns about the proposed ABC ordinance and how it would affect her business.
- **Christine Kuba** requested the city's budget be placed on the website.
- **Bernice Henderson** expressed opposition to the proposed ABC ordinance and concerns about its impact on local businesses.
- **Denise Henderson**, expressed concerns that the proposed ordinance would negatively impact her business.
- **Celeste Smith** asked the Council to consider the long-term impact the proposed ordinance could have on both current and future small business owners.
- **Duvon Perkins** addressed the Council regarding the same topic raised at a previous meeting concerning his business's use of the Community Center and wanted verification on the matter.

REPORTS OF OFFICERS, BOARDS, & COMMITTEES

Police Chief Victory Lynch – Officers will be recognized and awarded for their actions during an incident at Walmart. In a separate incident, officers recovered various illegal substances, including marijuana, cocaine, methamphetamine, and other items. The Police Department continues to work diligently to protect the citizens and appreciates the ongoing support and cooperation of the community.

Finance Director Matt Egbert – Responded to Council Member Leavell’s request for an update regarding the Tyler billing system. He reported that all other modules transitioned smoothly; however, the utility module has presented challenges. During the data conversion process, errors occurred, resulting in overages and underages on customer accounts. Egbert explained that there is no immediate fix, and billing accounts are being reviewed and corrected manually on an individual basis. Approximately 200 refund checks were issued last week as corrections continue. Customers experiencing billing issues are encouraged to contact the Utility Department, and staff will assist in reviewing and resolving their accounts. Egbert apologized for the inconvenience. He also reported that the KLC Investment Program has been established and is operational, and he is preparing for the FY 2025 Audit process.

Public Works Director Brian Ahart – Council Member Campbell commended Ahart for his efforts regarding trash service operations. Ahart recognized the Public Works Department for their continued dedication and discussed preparations for inclement weather. He reported that an employee is always on call, and additional crew members are available to provide assistance when needed. Ahart also provided an update regarding the storage shed project at the shop, noting that staff are awaiting approval of the building permit. The project is currently undergoing review through the county’s CDS process.

- **Code Enforcement in the City-Sponsored by Council Member Cook**
 - * Council Member Edward Cook inquired if the code officer’s workload was heavy and discussion about a part time officer was discussed. Council Member Janet Edwards asked the Code Enforcement Officer directly whether part-time assistance was needed, and the officer allegedly stated that additional part-time help was not necessary at this time.
 - * Baker noted that the last Code Board meeting was held in April and that two subsequent meetings were canceled due to a lack of a quorum.
 - * Further discussion was held on the matter.
- **Speed Limit Discussion-Sponsored by Council Member Campbell**
 - * A resident provided Council Member John Campbell with the applicable KRS regarding the matter. Council Member John Campbell stated that if an ordinance is adopted, it may require approval from the Kentucky Transportation Cabinet. Director Ahart is researching the issue.
 - * Council Member Janet Edwards reported that patrol efforts have increased. Council Member Richard Baker noted that reducing the speed limit to 35 mph would result in the same speed limit on both highways and city streets. Council Member Richard Baker questioned whether city street speed limits should also be adjusted, adding that making multiple changes would require additional maintenance and the replacement of numerous traffic signs.
 - * Further discussion was held on the matter.
