SECTION 4-EFFECTIVE DATE

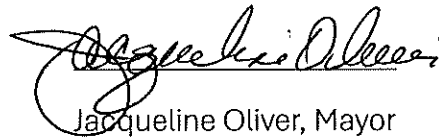
