- **Community Center/Parks and Recreation Director Eric Hauser:** Council to consider approval of an Improv Team to rent the gymnasium for a Murder Mystery Event with \$10 admission, and to host monthly free public events such as Comedy/Open Mic Night: Hauser reported that staffing has been established for the event and that he will coordinate with the Police Department to provide a police presence. They provided more insight regarding the event.
